attend the next meeting of the CEC to begin discussions on how to proceed and create guidelines. The owner Occupied Housing Rehab Program has been underway. Clint McQuiston and Scott Hamilton assisted the clerk with scoring the three businesses that applied for the lead based paint testing. Bid will be awarded at the next board meeting. Five homeowner applications were taken in and sent to WCNDD for review. It is possible that another round to accept additional applications will be opened up very soon. The goal is to have five homes qualified for the program. The Village Office will close at noon on Christmas Eve. According to the employee manual, employees are allowed to leave at noon that day without pay, or can use vacation or comp time. A survey regarding the park will be sent out to the Oxford and surround residents. There are 3 questions regarding the ball field and 3 questions regarding the shelter house. There is also a comment section for any additional areas of the park that may need upgraded. The clerk will obtain quotes for Plexiglas to be installed at the counter. The board has agreed to keep the office locked and will discuss again at the January meeting. The board reviewed the treasurer and investment reports. These reports are kept on file at the Village Office.

<u>Public Work's Director Report</u> the board reviewed the report from Hoffman. A copy of the Report is on file at the Village Office.
