A public hearing of the Chairman and Board of Trustees of the Village of Oxford was held in Open and Public session at the Village Office on September 8, 2022.

Notice of the public hearing was given in advance by publication and by posting in three prominent places in the Village, a designated method for giving notice. Notice of the hearing was given to the Chairman and all members of the Board, and a copy of their acknowledgement of the agenda was communicated in the advance notice to the Chairman and Board of Trustees of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The special meeting started at 7:08 P.M. and attendance was determined by Roll Call. Present were Chad Cunningham, Mike Minarik, Keithen Hamilton and Clint McQuiston. Absent: Scott Hamilton and Mike Minarik. Others present were Duane Hoffman, Public Works Director, Becky Calderone, Clerk/Treasurer and Angie Mitchell.

Board Chairman McQuiston informed everyone present that there is one current copy of the Open Meetings Act posted on the east wall of the meeting room.

Chairman McQuiston opened the Tax Request Hearing for the purpose of hearing support, opposition, criticism, suggestions, or observations of taxpayers relating to the following proposed budget, which has been available at the office of the clerk during regular business hours.

The board reviewed the budget notices along with the tax request notice for the breakdown the tax request of the Village OF Oxford as Well as for the Village of Oxford Community Redevelopment Authority.

There being no comment from the community, Chairman McQuiston asked for a motion to close the tax request hearings. Chad Cunningham made a motion to close the Village of Oxford Tax Request hearing as well as the Village of Oxford Community Redevelopment Authority Tax request Hearing, seconded by Keithen Hamilton. Roll call. Voting in favor:, Keithen Hamilton, Chad Cunningham and Clint McQuiston. Opposed: None. Motion carried.

There being no further business, the meeting adjourned by unanimous consent at 7:09 p.m.
