Notice of the public hearing was given in advance by publication and by posting in three prominent places in the Village, a designated method for giving notice. Notice of the hearing was given to the Chairman and all members of the Board, and a copy of their acknowledgement of the agenda was communicated in the advance notice to the Chairman and Board of Trustees of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The special meeting started at 6:34P.M. and attendance was determined by Roll Call. Present were Chad Cunningham, Mike Minarik, Keithen Hamilton and Clint McQuiston. Absent: Scott Hamilton. Others present were Becky Calderone, Clerk/Treasurer and Angie Mitchell.

Board Chairman McQuiston informed everyone present that there is one current copy of the Open Meetings Act posted on the east wall of the meeting room.

At 6:36 PM, Chairman McQuiston opened the Village of Oxford Budget Hearing for the purpose of hearing support, opposition, criticism, suggestions, or observations of taxpayers relating to the following proposed budget, which has been available at the office of the clerk during regular business hours. Chairman McQuiston also opened the Village of Oxford Community Redevelopment Authority budget hearing at the same time, for the purpose of hearing support, opposition, criticism, suggestions, or observations of taxpayers relating to the following proposed budget, which has been available at the office of the clerk during regular business hours.

The board reviewed the Village of Oxford Budget and The Community Redevelopment Authority budget. The board reviewed the Comparative Valuations, Levies and Taxes.


