RESOLUTION 2020-2-17

A resolution to set policy for dogs running at large within the Village of Oxford.

WHEREAS, the Village of Oxford Board of Trustees has the authority to set policy, and;

WHEREAS, it is necessary to set policy regarding the capture of dogs running at large, and;

WHEREAS, it is necessary to establish a schedule of fees to be charged to the owner or person harboring a dog captured running at large,

NOW, THEREFORE, BE IT RESOLVED that the following policy will take effect on February 17, 2020:

Dogs captured running at large will be held in a kennel in the back of the light plant. The dog will be held for five days after public notice is given. Notice of the impounded animal shall be posted at the Village Office within 24 hours of impoundment. Dog owners or persons harboring a dog shall pay the cost of the daily boarding fees of \$15.00 per day. In addition, a fine of \$15.00 for the 1st offense, \$25.00 for the second offense and \$50.00 for the third and each additional offense shall be paid to the Village of Oxford for dogs that have been licensed. A fine of \$60.00 for all offenses shall be paid to the Village of Oxford for unlicensed dogs caught running at large. The owner shall be required to comply with the licensing and rabies vaccination of the dog within 48 hours after release. Any dog may be reclaimed by its owner during the period of impoundment by payment of the costs of impoundment. Dogs not picked up after five (5) days will be euthanized.

Hamilton made a motion to approve resolution 2020-2-17, seconded by Cunningham. Roll call. Voting in favor: McQuiston, Cunningham, Minarik, Hamilton and McInturf. Opposed: none. Motion carried.

Oxford Swimming Pool wages: the Village board discussed some wage increases for the 2020 pool season. Wage ordinance as discussed will be on the next agenda for approval. Changes will be as follows: Manager: \$9.75 per hour, Assistant Managers; \$9.00 3rd Year and higher Lifeguards: \$8.50, 2nd Year Lifeguards: \$8.00.

<u>Turf Program for 2020 Growing Season:</u> Two P Turf presented the 2020 program growing season proposal. Cunningham made a motion to accept the proposal at the Pay 1 schedule, seconded by McQuiston. Roll call. Voting in favor: Hamilton, Minarik, Cunningham, McQuiston and McInturf. Opposed: none. <u>Clerks/Treasurer's Report</u>. Feral cat issue was discussed with the board. Village of Oxford Ordinance is as follows: **SECTION 3-307: DOGS AND CATS; NUMBER ALLOWED** No residential or commercial property within the village limits shall keep, harbor or maintain more than three dogs and three cats over four months of age. (Ord. No. 361, 6/4/07). Feeding feral cats falls under maintaining. The Village board asks for cat owner's to take responsibility for their own cat(s). Measures will be taken to address the issue. Please be aware that feeding more than 3 cats on your property violates the ordinance.

The Village board reviewed the Treasurer and Investment report, and said report is on file at the Village Office.
